

Section & Committee Nomination Form

In August, KCMBA will begin the process of selecting its new Section and Committee Leadership for 2012. Section and Committee activity is the lifeblood of KCMBA. Individuals are selected because of their expertise, leadership and commitment to KCMBA. Section and Committee leaders are responsible for building an effective team committed to professional and public service, while moving the membership towards accomplishing its tasks and goals. The process for Section and Committee leadership selection is described below.

Section Leadership: Section leadership consists of a President, President-Elect, Secretary/Treasurer, and two Members-at-large elected by the respective Section members. The President-Elect automatically succeeds to the office of President. The current Secretary/Treasurer may be nominated and elected to an additional term or may be nominated and elected to any other office. Each Member-at-large serves a two-year term, and may be nominated and elected for successive terms.

Committee Leadership: Committee leadership is comprised of a Chair (or Co-Chairs) and Vice-Chair (or Co-Vice-Chairs) and are appointed or designated by the respective Section President.
