**Selection Process**

- Select attorneys representing geographical, racial, gender, and private/public law practice.
- Admit maximum of 30 participants and a minimum of 20.
- Receive completed application form/participant agreement by deadline date.
- Letter of recommendation from an attorney or judge outlining why applicant should be selected to attend this leadership academy. Letter must be received by application deadline.
- Applicant may apply in subsequent years for future academies if not accepted.
- The selection committee consists of the Bar Leadership Academy Steering Committee and the KCMBA Executive Director.

**Registration Fee**

The registration fee of \$495 is to be paid after selection and prior to September 14, 2009. A limited number of scholarships are available; if interested, submit a statement of need with your application.
