**Regular Member:** Any lawyer in good standing with any Bar of any state is eligible to be a Regular Member of the Association. Regular Members must practice in at least one of the following counties: Cass, Clay, Jackson, Johnson, Lafayette, Platte or Ray in Missouri and Johnson or Wyandotte in Kansas.

**Public/Government Member:** Any lawyer who is employed full-time by a local, state, or federal government agency. Public/Government Members receive all of the rights and privileges of membership and are extended a 25% discount on regular dues.
